

ORDINANCE NO. 1072

ORDINANCE CORRECTING SCRIVENER'S ERROR IN ORDINANCE 1045, ENTITLED "ORDINANCE AMENDING TITLE 4, "BUILDING REGULATIONS", CHAPTER 3, "BUILDING CODES", SECTIONS 4-3-1 THROUGH 4-3-2, OF THE STILLMAN VALLEY VILLAGE CODE OF ORDINANCES ADOPTED AND APPROVED ON DECEMBER 9, 2024

WHEREAS, on December 9, 2024, the corporate authorities adopted and approved Ordinance 1045, entitled "Ordinance amending Title 4, "Building Regulations", Chapter 3, Building Codes", Sections 4-3-1 and 4-3-2, of the Stillman Valley Village Code of Ordinances";

WHEREAS, part of Ordinance 1045 adopted a new Fire Code to regulate fire codes as they apply to buildings within the Village; and

WHEREAS, the title of the published Fire Code as stated in Ordinance 1045 was incorrect; and

WHEREAS, it is necessary to adopt this ordinance to correct the scrivener's error as to the fire code referenced in Ordinance 1045.

BE IT ORDAINED by the Village President and the Board of Trustees of the Village of Stillman Valley, Illinois:

Section 1: That Section 2 of Ordinance 1045 is hereby amended to *delete* the reference to the "*National Fire Protection Association (NFPA), 2023 and 2024 editions*" on page 1, and "*NFPA International Fire Code, 2024 edition*" on page 2, in both places *insert* "*International Code Council International Fire Code, 2024 edition*".

Section 2: That Section 9 of Ordinance 1045 is hereby amended to delete the reference of "*National Fire Protection Association International Fire Code, 2024 edition*", in the second paragraph of Section 9 on page 5 of that ordinance, and insert in its place "*International Code Council International Fire Code, 2024 edition*".

Section 2: That the village clerk shall notify the proper state authorities of this correction.

Section 3: This ordinance shall be effective from and after its passage, approval, and publication as provided by law. This ordinance shall be published in pamphlet form.

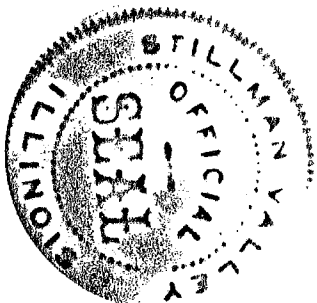
